<p>GOTS- Global Organic Textile Standard</p> <p>CU851413GOTS-01.2017</p>	>70%	-	<p>Conventional natural fibres All non-GMO natural fibres (except for conventional cotton) and any animal fibre except for conventional angora wool.</p> <p>Fibres regenerated from certified organic supplies, from pre-consumer or post-consumer waste or from certified waste in accordance with a program which verifies their compliance with healthy forestation principles The wastes must not be GMO; cellulose base (for example, lyocell, viscose, modal, or acetate) and protein base.</p> <p>Recycled synthetic fibres (polymers) from pre-consumer or post-consumer waste Only polyester, polyamide, polypropylene and polyurethane (elastane).</p> <p>Regenerated fibres (from non-organic raw materials) Raw materials should be non-GMO; their use is limited to a maximum of 10% or up to 25% for tights, stockings and sportswear.</p> <p>Virgin synthetic fibres (polymers) Only polyamide, polypropylene and polyurethane (elastane); their use is limited to a maximum of 10% or up to 25% for tights, stockings and sportswear.</p> <p>Stainless steel or mineral fibres, except for asbestos, coal and silver fibres Their use is limited to a maximum of 10%.</p> <p>The additional fibres can be mixed with the organic fibres in the fabric or used in certain details of the product. Mixing organic and conventional fibres of the same type in the same product is not permitted.</p>
